



NOTICE OF EDUCATIONAL OPTIONS FOR CHILDREN WHO RESIDE IN THE KIMBERLY AREA SCHOOL DISTRICT

The Kimberly Area School District offers a variety of educational options and programming to parents and children who reside in the district. The district's primary educational pathway for students involves a progression from Four-Year-Old Kindergarten through twelfth (12th) grade, leading to a high school diploma.

The district's schools, along with each school's most recent state-assigned Performance Category, are listed below. The Performance Category designation is from the 2022-23 school year. The district's Performance Category is also presented.

Other Educational Options

Parents/guardians of children who reside in the Kimberly Area School District also have a variety of other educational options available to them including the following:

- **Open Enrollment**

The inter-district public school open enrollment program allows parents to apply for their children to attend public school in a school district other than the one in which they reside. Any Wisconsin resident in 4K to grade 12 may apply to attend a nonresident school district under the open enrollment program. However, a child may transfer to a nonresident school district for early childhood education or 4K only if the child's resident school district offers the same type of program and only if the child is eligible for that program in the resident school district. - **Charter Schools**

Charter schools are public, nonsectarian schools created through a businesslike contract or "charter" between the charter governance board and the sponsoring school board or other chartering authority. - **Early College Credit Program**

Wisconsin's youth options program is an opportunity for students in grades 11 and 12 currently enrolled in a Wisconsin public high school to attend a Wisconsin postsecondary institution for the purpose of taking one or more courses for high school and college credit. There is no limit on the number of credits or courses a student can take through Youth Options each semester. Institutions of higher education are defined under the Youth Options statute as:

- University of Wisconsin System
- a technical college;
- a tribal college;
- Private Institutions (if they have completed their annual notice of intent to participate);
- nonprofit institutions of higher education (if they have completed their annual notice of intent to participate)

- **Part Time Open Enrollment**

Course Options allows students enrolled in Wisconsin public school districts to attend up to two courses at a time in a variety of educational institutions. Educational institutions are defined under the Course Options statute as:

- A public school in a nonresident school district;
- the University of Wisconsin System;
- a technical college;
- nonprofit institutions of higher education;
- a tribal college;
- a charter school; and
- a nonprofit organization that has been approved by the Department of Public Instruction (DPI).

- **Virtual Schools**

In Wisconsin, a virtual charter school is a specific form of online learning. It is the only form of online learning which allows an open enrolled pupil to participate remotely, that is, without having to physically attend school in the nonresident school district during all the days and hours that school is in session. - **Private School Choice Programs**

The Private School Choice Programs allow students to attend a participating private school if certain eligibility criteria are met. - **Special Needs Scholarship Program**

The Special Needs Scholarship Program (SNSP) allows a student with a disability, who meets certain eligibility requirements, to receive a state-funded scholarship to attend a participating private school. - **Home-Based Private Educational Program**

Under Wisconsin Statute 118.15(4), a parent or guardian has the right to select a home-based private educational program, commonly referred to as homeschooling, for his or her child or children, in order to comply with the compulsory school attendance law. - **Private School**

Parents have the option of enrollment in a private school of the family's choosing (at the family's own cost, as applicable). - **Youth Apprenticeship Program**

The Youth Apprenticeship program is a work-based learning opportunity for students in grades 11 and 12. Youth Apprenticeship combines industry directed, competency based, paid learning with classroom instruction.
